Regulation No. 1907-2006 aims to improve the protection of human health and the environment from the risks posed by chemicals. Updates to Section 6(h) of the Toxic Substances Control Act on January 6, 2021 published a final rule prohibiting the processing and distribution of 5 Persistent, Bioaccumulative and Toxic ("PBT") chemicals. PFAS


Perfluoroalkyl and polyfluoroalkyl substances have been shown to cause adverse health outcomes in humans, with studies indicating reproductive, development, liver and kidney, and immunological effects. In order to comply with various state legislations, Newtex Industries is requesting information regarding the presence of PFAS chemicals, including but not limited to perfluorooctanoic acid (PFOA) and perfluorooctane sulfonate (PFOS), in our raw materials.
